Membership Report: Rick Brown. Our membership dropped by one to 159 in the past month. This reflects the trends at both Regional and National levels. Club Reports:

Hocking Valley Model Railroad Club (Lancaster): Dexter Hill. Dexter reports the club remains on hiatus.

Janis Center Model Railroad Club (Columbus): Patrick Hreachmack. Patrick reports the Janis Center is still closed for the foreseeable future. The city is dragging its heels on the future of the Center.

Contest:

Virtual Photo Contest-Passenger Car: Jim Ruisinger. Jim reports this contest had an excellent turnout with some firsts. There were sixteen photos with no multiple entries and several first-time entries. The *Super's Signal* will have a recap of 2020 in a review.

Jim reported that a tie for Third Place went to Dave Richter (Photo # 1, Amtrak car from an overpass) and Rich Matejovic (# 15, a model of CP observation car). Photo # 14 placed Second, which is Mike Wolf's Senator Blowhard whistle-stop observation car. First Place went to Howdy Lamprecht (# 13, Martini Flyer at Olive Grove).

Members who voted this time selected three photos and ranked them 1, 2, and 3, instead of voting for only one photo. Jim reported that the results were the same as if we had voted the old way, but voting this new way could eliminate eight- or ten-way ties. There is currently a one-point difference between each pair of First, Second, Third, and Fourth positions for Photographer of the Year.

Starting in January, Jim will use the new voting system to tabulate points accumulation for the year. The 2021 schedule will appear in the *Super's Signals*.

White Spirit Pin Wash Warning

Lately, I've been using a very thin wash of Lamp Black artists oils diluted with artist's White Spirits thinner. This works very well for accentuating details. See the door rollers, locking hardware, and door guides on the left side of the accompanying photo for an example.

However, it has a side effect of affecting the underlying Dullcote. The result is that subsequent layers of weathering powders stick differently wherever the White Spirits went. See the door slider, doorstop, and the door guide on the right side.

You can mitigate the negative effect with targeted (or over-the-top grimy) weathering. Or you can clean the whole thing and re-Dullcoting. For new work, my approach will be to apply the pin wash before the initial Dullcote

layer, or as the final step after other weathering layers are complete. Especially on large, flat areas like car sides. I'll also be revisiting alcohol (or other less-aggressive) pin washes. Other advice is welcome – I'm still learning!

Just do it!

Why Wood Weathers the Way it Does

In November, I entered a photo of a weathered 36' Accurail double-sheathed boxcar. The caption read "A slightly worse-forwear T&OC boxcar sits in the late afternoon sun at Corning, Ohio, in 1923."

A photo from the fantastic color collection of Jack Delano inspired the weathering on that car. The MILW car pictured had, among other things, a variety of dark vertical streaks. Some of the wood siding was staining or degrading faster than others. More interesting, different parts of the same board exhibited good and bad sections.



By a lucky coincidence, a gentleman by the name of Andy Carlson, wrote about the processes behind this differential coloration a couple of weeks after that entry. If you are like me, understanding the "why" helps generate ideas on "how". An edited version of his description follows.

My interest in lumber has led me to examine photos of single sheathed freight cars critically. Unlike double sheathed cars, single sheathed cars usually did not have Tongue & Groove edges. Double sheathed cars not only had the T&G edges, but they were also commonly milled with a 'V' along the board's edge. This gave the characteristic finished look so attractive on both freight cars and passenger cars.

Logs milled into lumber start out as cylindrical. The mill saws



the logs into flat panels. The mill then saws the panels into individual boards. Sawing creates different styles of finished lumber depending on the location of this sawing relative to the circular ring pattern of the log. 'Vertical grain' or Quarter Sawn boards are where the tree rings, as viewed from the board's end, stand vertical. 'Plain Sawn' boards are where the ring grains run horizontally from side to side.

The favorite lumber to mill into Tongue & Groove was from oldgrowth trees. The darker forest made for minimal growth. This slower growth made for a much higher percentage of summerwood. As any old carpenter will tell you, that kind of lumber is the best, especially when Quarter Sawn into vertical grain wood.

Returning to the differences between Plain Swan and Quarter Sawn lumber. The face of the boards having the characteristic look of ovals and wavy lines are boards cut from the flat grain area of a slab at the mill. The ovals seen on the board are the rings exposed to the cut lumber. Since spring-wood is less strong, the flat grain on a board will have a higher percentage of weaker wood exposed to the weather.

I like to call attention to wood fence posts. Commonly beveled at the top to reduce the pooling of standing water, the tops of these boards clearly show the ring structure in the horizontal and circular view. After a few years, you will see that the areas within the rings will retreat downwards due to the softer spring wood's lower resistance to rot.

This same principle is at work on milled freight car siding. Since the common milling methods produce a mix of Plain Sawn and Quarter Sawn boards it was not uncommon for sheathing boards to also be a mix of mill cuts. After a few years, the boards with faces of predominantly Plain Sawn (spring-wood) will decay noticeably faster, as in the attached photo.

The difference between the boards with the paint intact vs. the boards with silvering weathering where the paint has flaked off

is striking. The boards which are in between Plain Sawn and Quar-Sawn have ring patterns varying from within the two extremes. They also will have a variable amount of face spring-wood and will show slower rotting of the Plain Swan wood but faster than the Quarter Sawn boards.

And now you know. Since weathering the T&OC car, I've found a tool that makes it a bit easier to apply Pan Pastels to individual boards. That will make it easier to better simulate




the effect in the lead photo in future weathering sessions. Oh, the same tool also works very well on running boards.

The tool is a "Colour Shaper" that I learned about in one of the NM-RAx videos. These are available in several con-

figurations – mine is a "Flat Chisel, Size 2". I'm still working on methods, with an early attempt displayed nearby.

Modeling Tip of the Month - 1-2-3 Blocks and Rare Earth Magnets

This month's modeling tip is about two modeling tools I've recently added to my toolbox. Matt Goodman discussed the use of machinist's 1-2-3 block previously in the *Super's Signal*. Based on a recent article in *Model Railroad Hobbyist Magazine*, I decided to purchase both a pair of 1-2-3 blocks and a pack of six rare earth magnets. Last weekend, I put them to work on a resin kit I was building. It had less than perfect mitered corners and I planned on using epoxy cement (see photo). I'm now sold on these new tools!

1-2-3 blocks are normally used by machinists to calibrate their tools. The company machined them to very tight tolerances of 1x2x3 inches with square corners. Milled from steel they are fairly heavy. There are a couple of different styles available. I chose the version with only a single hole in the center since they were the cheapest. I was primarily planning to use them to square up corners or provide weight for items drying to prevent warping. (i.e. stained or painted strip lumber).

The other new "tool" I obtained from Amazon were six rare earth super magnets. They are just a little larger than a quarter and they aren't kidding when they say SUPER! They come packed with nylon sleeves between them to help get them apart. There is a warning to handle them gently as they are fragile (from Italy for all those A Christmas Story fans out there). Not heeding that warning, I now have 5 super magnets — one of them slipped from my grip and "reunited" itself with his buddies and cracked into a bunch of pieces. They look like they are stainless steel but trust me they aren't. Did I mention they are super strong? Don't let them slip back together without the disc between them or you will likely need to use some sort of tool to get them apart.

That said, they worked like a champ holding the wall pieces in perfect alignment while the epoxy set up. As you can see in the photo, the magnets are holding the right wall in place despite having almost a 1/4" of resin between it and the machinist's block.

The other "tool" in the photo is my granite tile. I picked it up several years ago at Lowes or Home Depot. It has a very smooth, level surface, cleans up easily if you get some paint or adhesive on it, and works great for keeping everything "on the level."

If you decide to add these tools to your toolbox for 2021, search rare earth magnet or 1-2-3 blocks in Amazon or your favorite retailer and you'll find several to choose from. The two blocks went for around \$17 and the six magnets \$11.

I would appreciate your vote to continue serving as your Division 6 Director.




Mike Wolf, MMR
