#### FRA's Corridor ID Announcement Is Great for Ohio!

The Federal Railroad Administration's (FRA) Corridor ID Announcement identified Four Ohio Corridors:

- Cleveland Columbus Dayton Cincinnati (3C&D)
- Cleveland Toledo Detroit
- Pittsburgh Columbus Lima Ft. Wayne Chicago (Midwest Connect)
- Daily Cardinal Service AMTRAK

Each corridor will receive half a million dollars to study the next step. The State of Ohio is the sponsor for the first two corridors. A multiple-state group is the sponsor for the third corridor, and Amtrak is the sponsor for the Cardinal Service. The sponsors must use the money to develop a schedule and budget for the project's second phase.


The second phase includes choices about route, capital expenditures (like stations and support facilities), and phases of implementation. The choices are in cooperation with the Federal Railroad Administration (FRA). The State of Ohio will have to put up 10% of the cost of this planning phase.

Many, but not all, members of the Ohio Government are on board with improving passenger train travel in Ohio. This is different from about a decade ago when Ohio returned the money the state received to the federal government.

Community members must support the Governor and the legislators for passenger trains and the construction of both corridors.

#### All Aboard Ohio requests that you:

- Contact Senator Sherrod Brown (senate.gov) to thank him for his support of passenger rail
- Contact your state legislators (ohiohouse.gov and ohiosenate.gov), urging them to support passenger rail.
   Step 2 of the FRA process requires a 10% match of state money to move ahead
- Contact Governor DeWine (governor.ohio.gov) to urge him to fill the vacancy on the ORDC Board representing the interests of passenger rail. And to thank him for advocating for passenger rail to the ORDC
- Send a letter of gratitude to William Murdock at MORPC (www.morpc.org) for advocating for passenger rail




#### Some things to remember

- •The state has a two-year budget cycle, and it's essential to fund both steps 2 and 3 in the 2025/2026 state budget cycle
- •Construction can begin during the next budget cycle
- •Actual service starts around 2030
- •No specific asks as of this time
- •Send positive letters about the two funded-FRA Corridors to state legislators
- •Include something personal. I'm going to enjoy going to a Browns game without having to drive



Have you ever heard the phrase "One man's trash is another man's treasure"? I'm not particularly eager to refer to model railroad items as trash, but they are treasures. Those items in our model railroading stockpile no longer meet our main line interest. Rolling stock items sitting on a sidetrack, structure kits in hopes of building, or memorabilia items that no longer have steam. You get the idea. Did

you know the raffle depends on donations from division members? It's true! So look at those items that no longer meet your railroad's main line needs and consider donating one or more. #### Hello Friends

Some of you remember me, some probably do not. I'm writing to you with a request.

After many years of living in a house, last March, medical issues forced me to move into a senior living facility. As part of that process, I had to dispose of my collection of trains, model railroad supplies, accessories, etc. It just wouldn't fit into a studio apartment. I kept a few pieces. I expected I'd be finished with my days of model railroading. Once here, I met a neighbor in essentially the same situation. We had been thinking about building some minimal layout to keep in our apartments. We both realized that such an undertaking wasn't very practical.

While discussing this, we thought, "Why not try to form a club here and see if we can get some space to build a layout?" After some discussion with the facility managers, they granted us the use of a space 10 feet by 25 feet, and we were off. The facility even supported us to the extent that they provided materials for some initial benchwork. The idea is taking off, and we now number six or seven members. Some experienced model rail-roaders, and some are new to the hobby but very interested. We also have several people interested in the endeavor's scenery aspects but not the trains specifically. It's amazing to see how excited people who thought their

time with the hobby was over get at the prospect of continuing and doing it with several like-minded individuals. But we need much more than a few tables.

One of the very first things we did was develop a set of standards for the proposed layout. The central part of this was the dimensions of the benchwork. We have many people here with mobility issues and need to accommodate them. The mobility issues impose limitations on how high the benchwork can be, how deep it can be, and how much clearance we need underneath. Researching this, we couldn't find any guidelines, so we developed our own. We believe that a layout built to these standards will allow a person in a wheelchair to both work on the layout and run trains. As you may know, living in a facility like this is not cheap, and as retirees, we don't have much money.



We need Code 100 or Code 83 flex track, switches, roadbeds, scenery supplies, rolling stock, and locomotives, about everything you need to build a model railroad.
