**Highlights:** Matt Goodman.

Matt discussed highlights of the division's accomplishments for 2023. *The Cambridge Train Show* was very successful. The car project (Buckeye Steel Castings gons) has been underway since August. Buy cars from Greg Short.

**Policies and Procedures Manual:** Don Wilke and Butch Sage have written a draft *Policies and Procedures Manual* (PPM). They designed the PPM to give current or prospective officers or chairs a description of their duties. The Board of Directors will vote on the PPM at its March meeting. Nominations and Elections Report: Butch Sage. Nominations for the four Officer positions will close at the Division 6 Meeting on February 18. We still need a candidate for Superintendent. Matt promoted the position, and Greg said it was an easy job.

**Buckeye Express 2025 Convention:** Greg Short. We have a good core committee and are well on our way. We need to fill some positions, such as organizing clinics, overseeing the contest room and the company store, and organizing programs. Terry Bacus will be our T-TRAK Coordinator for the Convention. Greg can put a list of needed jobs in the Super's Signal. We need to prepare a presentation for the May 2024 Convention banquet. It covers when, where, and how much the 2024 Convention costs. The hotel Contract is signed, and the room-night rates cover the costs of the meeting spaces. Establishing our 501(c)3 status will save us the 7-1/2% tax rate on the banquet cost. The Convention Committee first met on January 11 and will meet next on February 22 at the New Albany Library.

#### **Economic Benefits of Amtrak Service to Central Ohio!**



The *Columbus Dispatch* recently ran an article by Mark Ferenchik about the economic benefits of a new Amtrak service to Central Ohio.

The non-profit rail advocacy group *All Aboard Ohio* commissioned an economic impact study by *Scioto Analysis*. The study found that ongoing ridership would generate \$3.9 million to \$7.2 million in new wages annually. The study is at allaboardohio.org.

Rob Moore of *Scioto Analysis* said annual ridership in Columbus would be 133,000 to 268,000 yearly. The new Cincinnati-Dayton-Columbus-Cleveland service would initially create 400-520 jobs, with 60 to 110 jobs a year after that.

The economic impact in Greater Columbus would be \$36 million to \$48 million at first, with a \$9 million to \$16

million annual impact a year after that.

Moore said that the study estimates that the initial investment for service between Cincinnati, Dayton, Columbus, and Cleveland would generate \$106 million to \$107 million in gross state product. After that, the corridor would continue to contribute \$25 to \$47 million to gross state product per year through ridership.

The service would also help the environment by reducing car pollutants. It would help reduce the number of vehicle crashes because of fewer automobile miles traveled, he said.

The federal government provided \$500,000 for planning for each of the four routes for this planning round.

The \$500,000 is to prepare cost estimates for the state and local governments matching funds for future planning rounds. The following planning round requires a 10% matching fund. It would determine the basic structure, best route, station locations, passing sidings, train length, frequency, etc. It would propose a budget for the next planning round and determine the construction cost.

Passenger trains would share the track with freight trains, and freight trains get priority. John Esterly, an *All Aboard Ohio* board member, said there are concerns about capacity, but he said there is room for Amtrak.

Marc Magliari, an Amtrak spokesman, said Amtrak recognizes that trains must be competitive with freeways. "Speed's important," he said. But he said what drives ridership is reliability, frequency, and competitive fares.

Erin Rosiello, *All Aboard Ohio's* chair, said, "You're not going to replace cars, that's never going to happen." But trains would help reduce traffic congestion and provide options for people without cars or driver's licenses, she said.

Service isn't expected to come to Columbus until 2030 at the earliest. The last year Amtrak passed through Columbus was 1979, a route between Kansas City, Missouri, and New York City.



Join us at the Barnett Library (formerly the Livingston Library) in February. Matt Goodman will trace the *Cycle of Water Through a Steam Locomotive*, beginning with its introduction into the boiler and the appliances on the locomotive that it passes through. He'll also discuss water treatment and water delivery.

Bob Baker will present *Canadian Pacific Railway: The Big Hill and Spiral Tunnels* in March. The CPR completed its transcontinental line in 1885. The CPR faced significant operational challenges presented by a section of 4.5% grade through the Kicking Horse Pass. Bob will discuss the historical context of the line's original construction and operations on the "Big Hill" from 1885 until 1909, when the Railway constructed the Spiral Tunnels to remedy this situation. Bob will illustrate the construction of these tunnels, the line's new alignment, and operations with maps and photographs.

Lastly, in April, plan on a Bring and Brag session. Save examples of your recent modeling (or blow the dust off older ones) to share in this easy-to-prepare format.

Two clinicians have volunteered for our Marion meeting in June, but I still have plenty of openings throughout 2024. As Matt mentioned at the meeting, it's an excellent time to practice your clinic, as we'll need many volunteers to present at our Regional Convention in 2025.

To receive the Chief Dispatcher Award, Dexter participated in the operation of a model railroad, either home or club, for not less than fifty hours. Dexter served a minimum of ten hours each must have been served in three of the five categories listed below, one of which must be the last one, Dispatcher:

- Engineer (mainline freight, passenger, or wayfreight)
- Yardmaster (or station master)
- Hostler (or power desk)
- Tower man (or traffic manager or road master)
- Dispatcher

Dexter accumulated experience on one or more model railroads with at least two mainline trains and yard switching in simultaneous operation. Some freight and passenger car movement systems, including road switching, shall be used to control train activity.

GOLDEN SPIKE AWARD QUALIFICATIONS CHECK-LIST:

1. Rolling Stock (Motive Power & Cars):

Display six units of rolling stock, either scratch-built, craftsman kits, or super detailed commercial kits.

2. Model Railroad Setting (Structures & Scenery):

Construct a minimum of eight square feet of model railroad or module(s), including scenery in any scale. Construct five structures: scratch-built, craftsman kits, or superb detailed commercial kits. If a module has less than five structures, additional structures separate from the scene may be presented.

3. Engineering (Civil & Electrical):

Three types of track are required (e.g., turnout, crossing, crossover, etc.). All must be ballasted appropriately and installed on the proper roadbed. Commercial track may be used. All installed tracks must be correctly wired so that two trains can be operated simultaneously (e.g., double track main, single track main with sidings, and block or command or other form of control). Provide an additional electrical feature such as power-operated turnouts, signaling, turnout indication, lighted buildings, etc.

## Don't Just Belong, Participate!!

#### Hello Friends

Some of you remember me, some probably do not. I'm writing to you with a request.

After many years of living in a house, last March, medical issues forced me to move into a senior living facility. As part of that process, I had to dispose of my collection of trains, model railroad supplies, accessories, etc. It just wouldn't fit into a studio apartment. I kept a few pieces. I expected I'd be finished with my days of model railroading. Once here, I met a neighbor in essentially the same situation. We had been thinking about building some minimal layout to keep in our apartments. We both realized that such an undertaking wasn't very practical.

While discussing this, we thought, "Why not try to form a club here and see if we can get some space to build a layout?" After some discussion with the facility managers, they granted us the use of a space 10 feet by 25 feet, and we were off. The facility even supported us to the extent that they provided materials for some initial benchwork. The idea is taking off, and we now number six or seven members. Some experienced model railroaders, and some are new to the hobby but very interested. We also have several people interested in the endeavor's scenery aspects but not the trains specifically. It's amazing to see how excited people who thought their time with the hobby was over get at the prospect of continuing and do-

ing it with several like-minded individuals. But we need much more than a few tables.

One of the very first things we did was develop a set of standards for the proposed layout. The central part of this was the dimensions of the benchwork. We have many people here with mobility issues and need to accommodate them. The mobility issues impose limitations on how high the benchwork can be, how deep it can be, and how much clearance we need underneath. Researching this, we couldn't find any guidelines, so we developed our own. We believe that a layout built to these standards will allow a person in a wheelchair to both work on the layout and run trains. As you may know, living in a facility like this is not cheap, and as retirees, we don't have much money.




