# Clinic

# Automating a Walthers Turntable using Arduino, Bill Morgan

At 2:15, the members in attendance decamped to the back of the room for Bill Morgan's clinic on automating a Walthers Turntable using the code he developed and deployed to an Arduino. The project also included various 3D filament-printed parts, with the goal of not modifying any existing Walthers parts. The project also featured stepper motors and, in one instance, a clutched gear wheel to safeguard the stepper motor in case something obstructed the gear train. Bill then showcased a turntable module from his layout and circulated various parts for inspection by the members. Bill is open to consulting and assisting with similar projects from other members, but he isn't interested in producing complete kits.

# Butt-Joining Pink Foam Panels for a Solid Scenery Base

I'm using rigid insulation foam to support the scenic, non-roadbed areas on my layout. I chose a 2-inch thick foam to match the height of my spline roadbed and thought the thicker foam would provide a sturdier base between the benchwork supports.


One issue with this is that joints between foam sections don't always align conveniently with a supporting structure, creating a weak spot. Scenery like buildings and other items placed on the foam isn't very heavy, but I was confident that I could stack things on it while working, which could lead to sagging. Additionally, these types of foam joints have been reported to "open up" over time. Both scenarios necessitate a continuous foam sheet.

After considering several options for joint support, including sub-joists and splice plates, I noticed a can of Great Stuff. Anyone who has used this product knows that, in addition to expanding to effectively fill voids, it is also very sticky. I decided to try something akin to a biscuit joint in woodworking, with Great Stuff acting as both the biscuit and the filler glue.

I completed this project six years ago, and it's holding up very well. The following are photos and descriptions of the steps I took.

# **Preparing the Insulation Foam**

I cut a slot in the ends of the adjoining foam pieces with a hotwire knife, which is the perfect tool for this, about 1 to 2 inches deep. An extending blade utility knife could also work.



I also added vertical "ports" to create a space for excess foam expansion. My thought was that these ports would

stop the Great Stuff foam from forcing the two sheets of insulation foam apart as it expanded.




Figure 2 (Photo by Matt Goodman)

# **Applying Great Stuff**

Separate the sheets and fill the slots of both with Great Stuff (not shown) to avoid any voids in the slots, then push the two sheets back together before it has a chance to start dripping on the floor.

I injected additional foam into the expansion ports as needed. I injected a sufficient amount to ensure the foam expanded into the deeper areas of the slots.




Figure 3 (Photo by Matt Goodman)

# Cleanup (above)

After the Great Stuff cures for about a day, trim the excess expanded foam flush with the insulation sheet, and then you're done. A utility knife blade is ideal for this task.

### Result


Voila: a sixteen-foot continuous slab of insulation foam supported at the glued joint with no flex. This worked as well as I had hoped it would at the time.

# **Joint Cross Section**

A couple of months later, I cut a slot in the foam for the spline to support the Old Main. This cut offered the chance to see what the Great Stuff joint looked like in cross section. I had been curious whether the foam filled the slot completely (it did) and if any large voids had formed (it didn't)
